FOP SCHOLARSHIP PROGRAM - URGENT!!!
 Information related to the NYS FOP Scholarship Program, along with an application, can be found on the State Lodge web site (www.NYSFOP.org). However, as a reminder for our Members I have included the pertinent information below. If you have a child who is completing his/her eight year of school and entering the ninth year or a high school senior who is planning on continuing his/her education in some

form, they will be eligible for one of our Awards (you may have more than one child eligible). Recipients will be chosen by lottery drawing in the end of May. The awards will be presented at the Scholarship Awards Dinner in June. Winners will be notified by telephone. **VERY IMPORTANT - ENTRIES MUST BE RECEIVED NO LATER THAN MAY 1ST, 2010, TO BE ELIGIBLE FOR THE DRAWING.** Even though it doesn't say so in the application, you must include a copy of S.A.T. scores or Letter of Acceptance from

a college. There's not much time, so don't delay. Remember, the application may be obtained from the FOP web site, or contact one of our Executive Board Members. Completed applications must be sent to the NYS FOP Scholarship Program, 911 Police Plaza, Hicksville, NY, 11801, or FAXed directly to FOP HQ at (516) 433 4473. Good luck - Pat C.

HR 218

Legal Defense Plan

For those of you who have qualified to carry firearms under the "HR 218" law, the Grand Lodge offers a Legal Defense Plan. Legal defense coverage will be provided for civil or criminal claims associated with the HR-218. The annual coverage limit will be \$15,000 at a cost of \$50.00 per participant. The application for coverage can be found at www.grandlodgefop.org under Programs, then Legal Defense.

HR 218 UPDATE

We all know that several years ago HR 218 was signed into law by then President George W. Bush. We thought that this law would give us the right to carry our weapons almost anywhere in the US. However, we know that this did not happen. Certain amendments to the original bill set forth requirements for retired officers concerning training and certification that are beyond our control to meet. The National FOP has recognized these problems and, for several year, has

(Note: In the past, the State FOP provided a \$50 reimbursement to each delegate or alternate who took the place of a delegate at the conference. However, because of fiscal constraints, this reimbursement WILL NOT be provided this year.) Second we have to elect our Lodge Trustee. The Lodge Trustee is our representative at all State Board meetings and must be willing and able to attend those meeting which are held bi-monthly at FOP HQ. Anyone inter-

ested in running for the position of Lodge Trustee must be a member in good standing and must have been a member for at least 6 months prior to the Luncheon Meeting to be eligible. The candidate should attend the luncheon; however, if this is not possible, the candidate can still be considered for the position by submitting a signed letter as indicated above. However, even if you're not interested in any of the positions mentioned above, COME TO THE LUNCHEON! You'll get a chance to see old friends and reminisce. Hope to see you there.
