### REAL ID

A REAL ID is a federally compliant DMV issued driver license, learner permit, non-driver ID, or a valid passport, which you will have to have to board a DOMESTIC flight or enter certain federal buildings starting on MAY 7<sup>TH</sup>, 2025.New York State offers 3 types of ID's: Enhanced Driver License – this is federally compliant, REAL ID – non-driver license, but federally compliant, and Standard Driver License – NOT federally compliant. The deadline is a little more than one year away, but if you plan on doing any air travel in the future power than the time to get your ID agreed away.

MEDICARE PART B REIMBURSEMENT—By the end of April most of our retired members on Medicare and their Medicare-eligible dependents should have received their Medicare Part B reimbursement for 2023. The reimbursement will be deposited in the same bank account in which you receive your pension check. If you receive a hard check for your pension, your reimbursement check will be mailed to you. For 2023, the standard Medicare Part B reimbursement is \$164.90 per month (total of \$1978.80 for 12 months per eligible individual). For more info or for an application search NYC Health Benefits Program and look for Medicare Part B reimbursement.
